

The Applicant School has filed this Revision Application under section 12 (3) of the Gujarat Self Financed Schools (Regulation of Fees) Act, 2017, (for short 'The Act, 2017') read with Rule 14 of the Gujarat Self Financed Schools (Regulation of Fees) Rules, 2017 (for short 'The Rules, 2017'), being aggrieved by and dissatisfied with the order passed by the Fee Regulatory Committee, Ahmedabad Zone (for short FRC) File No .FRC/Gandhinagar/DEO/Proposal/332/Final Order/2024-25/3023-25 on 24/01/2025 dispatched on 06/02/2025.

(2) The Meeting of Fee Revision Committee is convened and commenced hearing of the case in terms of Rule 15(5) of the Rules, 2017. The Notice of hearing was issued to the Applicant School to remain present on 07/05/2025 and produced documentary evidence under Rule 14(4) and Rule 16(1)(iv) of the Rules, 2017. On 07/05/2025 the Applicant School has filed adjournment application to grant time for production of documentary evidence which was granted by this Committee.

(3) The Applicant School had made proposal on 20/11/2023 presented in FORM II for the standard pre-primary to standard 12 of the Academic Year 2024-25 before the FRC Ahmedabad Zone for approval of Fee Structure.

The FRC Ahmedabad has passed Final Order on 24/01/2025 and dispatched on 06/02/2025 by which the proposal has been partially granted with certain conditions as under.

(3.1) It appears that FRC Ahmedabad has consider 5% surplus in the fees for the Academic Year 2025-26 and 2026-27.

(4) The record and proceeding of FRC Ahmedabad has been called for and perused by the Committee.

(5) The Applicant School has sent letter outward no. 116/2025-26 dated 28/05/2025 to withdraw Revision Application, wherein it is stated as under:

" With reference to the above, we refer to the personal discussion we had with Hon'ble Chairman of the Fee Revision Committee on 6th May, 2025 against Final Order No. FRC./Gandhinagar/DEO/332/Final Order/2024-25/3023-25 against our objection raised vide our letter dated 18th January, 2025.

...

After careful consideration, we had decided to withdraw our objections against the aforementioned order. The academic year 2024-25 has concluded, and the fees have already been collected. Requesting parents to pay additional fees would be challenging and could lead to conflicts between the school management and parents. Therefore, we believe it is in the best interest of all parties to accept the final order and move forward."

(5.1) The applicant School has filed copy of resolution no.1 of the meeting dated 28/05/2025 of the Anand Uthan Trust whereby it is resolved that the revision application no. 07/2025 for the proposal of the AY 2024-25 be withdrawn unanimously and final decision will be taken by the Shri Vivekbhai Patel.

(6) The Committee has considered the proposal Form no. II, Annexures submitted with the proposal, documentary evidence produced before this committee and FRC, contents of the letter dated 28/05/2025 of the school and resolution submitted with it, legal provision and facts and circumstances of the case.

Applicant School has accepted the fees decided by the Fee Regulatory Committee for the year 2024-25 as per FRC order dated 24/01/2025. As per Rule 14 of the Rule, 2017, the Fee Revision Committee after considering the R & P of FRC and giving reasonable

opportunity of being heard to the Applicant may confirm, revise or cancel the order against which the Revision Application is preferred. This Committee is of the view that the reasons stated to withdraw the Revision are genuine. Withdrawal of Revision Application is required to be granted, hence following order is passed.

ORDER

The Revision Application is hereby disposed off as withdrawn.

The Applicant School has to comply the terms and condition of the order no. FRC/Gandhinagar/DEO/Proposal/332/Final Order/2024-25/3023-25 on 24/01/2025 passed by the Fee Regulatory Committee Ahmedabad Zone.

It is further clarified that the fees determine by the FRC Ahmedabad will be implemented for the Academic year 2024-25, 2025-26 and 2026-27 and in case of any contravention, the penalty may be imposed by the FRC Ahmedabad.


